Established leaders shared unique perspectives and insights in a Business Council panel discussion focused on "Leadership Trends in 2024 & Beyond". The panel was moderated by Natasha Chandler, Monmouth alumni, Business Council member and Senior Client Partner at Korn Ferry, a global organizational strategy and management consulting firm.

Natasha kicked off the session by sharing leadership trends published by Korn Ferry's Research Institute on the shifting dimensions of what great leadership looks like in corporations and industries. Message from the Chair



I hope the new year is off to a great start for everyone. As the fall semester comes to a close, it's a great time to recognize a few notable Business Council efforts and impact these programs are having on students of the Leon Hess Business School.

First is our student scholarship and awards program. This academic year we have enhanced our student financial support to more than \$50,000 with 3 annual scholarships, 2 endowed scholarships and 6 awards. This fall, 4 business school students were awarded Business Council scholarship funds helping to offset tuition expense.

Another fall semester highlight is the Executive Mentoring Program. This year's offering was expanded to integrate career development team support and tailored programming based on where students are in their career journey. We've seen a jump in participation with more than 85 students working directly with 40 business executives in both group and 1x1 mentoring settings.

Professor-In-Residence Program

The Professor-In-Residence Program is a pilot groundbreaking initiative aimed at fostering meaningful collaboration between academia and the corporate world. The purpose of the program is to bridge the gap between theoretical knowledge and real-world application in the board room as well as the classroom. The professors immersed themselves in the daily routines of executives from the LHBS Business Council. which entailed shadowing these executives as they navigated the intricacies of their respective industries.

This was a joint effort between the Corporate Relations Officer and the LHBS Department Chairs. Their task was to select faculty members who possessed expertise relevent to the Business Council's diverse fields.
