### **Business Council Meeting Features Three New Initiatives**



### Message from the Chair

The Business Council's quarterly meeting on February 23 focused on the importance of experiential learning with several programs supported by Council funding, member mentoring and affiliated corporate participation.

Students today need work experience prior to entering the job market. It has become evident that a degree is not enough. This is underscored by the NACE Job Outlook, which cites that 91% of employers prefer entry-level candidates to have work experience. In the past, this experience came in the form of internships only, but we're now offering our students a variety of opportunities that help them gain experience in applying their knowledge, as well as developing their collaboration and communication skills.

The Business Council also provides opportunities for part-time work, work study, field trips, project-based learning, research and extracurricular activities. Two new pilot programs were highlighted during the February 23 meeting.

Business Council member Michael Troy hosted Professor Mikhail Sher to experience a "Professors-in-Residence" day at Troy Container Lines where he was able to apply what he learned in the classroom in a real-world environment. Professor Sher, Michael Troy and LHBS junior, Kyle Bleiweis shared their personal testimonies of the new program's benefits.

Also, Julia Angeliadis, Career Development Outreach Coordinator, was there to share about the newly launched micro-internship program offered through Career Services. This links companies who have project-based initiatives with students seeking short-term experiences to produce tangible work product for pay.

Together, these new programs are providing students with new and innovative opportunities that will enable them to thrive and land the job they want and succeed!

# Guest Speaker: Dr. Richard Veit, Interim Provost & Senior Vice President for Academic Affairs



While at our meeting, Dr. Veit opened his remarks by offering gratitude to Business Council members for the generosity of their time, talents, and resources.

He also underscored the importance of complimenting knowledge learned in the classroom with experiential learning opportunities provided through executive mentoring, internships and student led projects.

In addition, Dr. Veit spoke to some of the challenges and opportunities facing the university including declining enrollment, changing demographics, and the need to continually evolve and adjust to remain relevant. He conveyed optimism and excitement around the university's strategic plans and future.

#### About Dr. Richard Veit

Dr. Veit, a Professor of Anthropology and former Associate Dean in the School of Humanities & Social Sciences, became the Interim Provost last fall.

The key responsibilities of the Provost position include: academic planning, policies and practices. It also involves providing guidance to the deans of each school within the university and making resource allocation decisions related to funding.

Veit received a Bachelor of Arts degree from Drew University, a master's degree in Historical Archaeology from the College of William and Mary, and a PhD in Anthropology from the University of Pennsylvania.

An accomplished educator with more than 25 years at Monmouth University, has authored/co-authored five books and numerous articles. His research has been featured on NPR, *Archaeology Magazine* and TEDx Navesink.

Dr. Veit serves on the New Jersey Historical Commission, the boards of the Council for Northeast Historical Archaeology, Crossroads of the American Revolution and the Archeological Society of New Jersey. He is also the President of the Middle Atlantic Archeological Conference.

# **Professors-in-Residence**

The Professors-In-Residence as previously mentioned is a pilot program whereby members of the faculty spend a portion of a day shadowing an executive from the Business Council as they go about a normal working day in their respective industry. The goal of this initiative is multifaceted. We want the business professors to get a glimpse of how their lessons can be applied to real world applications. On the flip side, we want students to see what they are learning being used in private industry to better prepare the students for their careers. It is crucial for students to be able to connect classroom theory and practical applications.

The coordination of this initiative is the responsibility of the corporate relations officer and the department chairs to select faculty professors and match with members of the Business Council in their respective fields of expertise.

This past semester, the four business faculty members who participated in this new initiative were: Dr. Daniel Li, Accounting; Dr. Mikhai Sher, Management; Dr. Anna Sadovnikova, Marketing; and Dr. Jonathan Daigle, Economics, Finance, & Real Estate. A big thank you to our Business Council Members, Thomas Cardinale, Michael Troy, Nicole Puccio and Erin Moran for taking time to make this initiative successful.

Because of this program, a great synergy evolved between Professor Mikhail Sher and Michael Troy. Dr. Sher has invited Michael Troy to participate in several of his classes to discuss supply chain operations in the real world. Michael Troy discussed the recent impact of the collapse of the Baltimore Harbor Bridge on the international supply chain.

Michael told the class how involved he was with his clients in Asia in moving the goods to their respective destinations. There was also an active Q&A session afterwards. Students were not only engaged in asking further questions about supply chain operations but also the opportunities at Troy Container Line for internships and full-time positions.


