SENIOR SYDNEY STRICKLAND PRESENTS HER RESEARCH AT STUDENT SCHOLARSHIP WEEK

On Monday, April 17, 2023, Sydney Strickland presented her research titled "Examining if Crisis Intervention Team Training Improves Officer Confidence in Communicating with Emotionally Disturbed Persons While in the Field" at the Hawk Talks event at Monmouth University's 2023 Student Scholarship Week. The Hawk Talks event highlights the rich diversity of events offered during Student Scholarship Week by including student work from all academic disciplines, including graduate and undergraduate students, in one premier interdisciplinary event.

Sydney Strickland's research examined the effectiveness of Monmouth County's Crisis Intervention Team Training (CIT), which is a nationally recognized approach that allows the gaps between the mental health and the criminal justice systems to be bridged to provide a safer, smarter, and more understandable way of assessing and addressing the challenges regarding an individual in crisis. Findings revealed that after completing CIT training, officers' confidence in engaging with individuals in crisis improved. Sydney completed her research as part of Monmouth's Summer Scholars program, where students live on campus with other student researchers and work collaboratively with a faculty mentor on a scholarly project. Sydney was advised by Dr. Meg Forney.

DR. THOMAS CAREY AND GRADUATE STUDENT MATTHEW PRINGLE PRESENT THEIR RESEARCH

Thomas J. Carey, Ed.D., Specialist Professor of Homeland Security, and graduate student Matthew Pringle, presented their research "Harnessing Emerging Technologies in Emergency Management" at FEMA's Higher Education Roundtable at New Jersey City University on March 28. The presentation focused on using global information systems and drone technologies in Homeland Security.

Pringle showcased his research on COVID-19 and wildfire GIS applications. He also shared the spotlight with classmate Orlando Ferreira Neto, whose research, "Can a low-cost drone survey replace a high-cost LiDAR survey for building information modeling of a flood risk assessment?" focused on the use of drones in the homeland security space.

Carey highlighted the value of implementing technology inside and outside the classroom using various types of experiential learning activities. "High-impact learning can be achieved through the coupling of technology as the driving factor in supporting the pedagogy of experiential learning," he said.

Carey also discussed how drones are utilized in each of the four phases of emergency management: mitigation, preparedness, response, and recovery. He concluded his part of the presentation with a discussion on all-terrain vehicles and robotics.

At the conclusion of the roundtable, Martin Walker, Ph.D., Dean of the College of Professional Studies at New Jersey City University, recognized Pringle for his dedication and hard work inside and outside the classroom. Pringle received his M.A. in Criminal Justice in August 2023 and served as the president for the Homeland Security Honor Society, the Order of the Sword and Shield Honor Society, Omicron Sigma Sigma. He is a volunteer firefighter for the town of Belmar, NJ.

Professor Fazari holds a Ph.D. in higher education administration from Seton Hall University where he also earned a Master of Public Administration and a Bachelor of Arts in criminal justice. He is a Fellow of the Institute for Court Management and was the recipient of the Vice-President's Award of Merit for Applied Research. Before working in academia, he was a court executive and chief administrator for the New Jersey Judiciary. He has served as a consultant for several domestic and international organizations including the Rodrigo Lara Bonilla Judicial Training School of Colombia, Supreme Court in Ukraine, and the Federal Judiciary and National Industrial Court of Nigeria, where his areas of expertise included case management, court security, and business process reengineering. He was a Lead Developer and Subject-Matter Expert

for the National Association for Court Management's Core Competencies for Court Administrators and has been published in a variety of journals. He is the writer and director of the award-winning feature documentary, Why They Kill, based on the book by the Pulitzer Prize-winning author, Richard Rhodes. He is co-author of the book, Historical Dictionary of American Criminal Justice, and author of Courthouse Confidential: Unveiling Lessons Learned in Leading and Managing Trial Court Organizations.

This past summer I was given the opportunity to intern for Jersey City's Office of Homeland Security & Emergency Management. My duties included assisting my supervisor and other members with the day-to-day operations of OEMHS and other public safety agencies within the city. I responded to major emergencies citywide such as fires, partial building collapses, major power outages, and learned to operate and maintain certain types of equipment including light towers, generators, and mobile camera trailers. In addition to those duties, I was able to witness how planning for important events was conducted, as well as participate in multiple community policing events with the Jersey City Police Department.

This experience was truly one of a kind and I couldn't have asked for anything more. I valued how hands-on this internship was and how everyone was eager to teach me the job. It was enjoyable to see how some aspects of the homeland security courses I have taken here at Monmouth play into real world scenarios. My biggest take away from this internship was the networking and connections I made throughout the summer. I was able to work alongside Directors, Chiefs, and Deputy Chiefs of all the public safety agencies within the city.

This past summer, I had the privilege of interning with the Seminole County Sheriff's Office (SCSO) in Florida, specifically within the Domestic Security Division's Counterterrorism Unit (CTU). During my internship, I played a pivotal role in School Threat Management data analysis, constructing timelines for potential threats, and conducting phone dumps for individuals with suspected links to overseas terrorist activities. In addition to these responsibilities, I actively participated in meetings, briefings, and attended significant events, such as the Threat Assessment and Threat Management initiative (TATM) hosted by the FBI and our county's annual Fourth of July fireworks event.

When I embarked on this internship, my primary goals were to expand my professional network and gain invaluable experience. I am thrilled to report that my expectations were not only met but exceeded during my time at SCSO. Through a diverse range of experiences, I witnessed firsthand the importance of collaborative teamwork, especially between agencies. My internship at SCSO not only equipped me with new skills and knowledge but also provided exceptional clarity regarding my career aspirations within the field of Homeland Security, all due to the vital connections and relationships developed here.
