**TO REGISTER BY PHONE:** Call (732) 571-3660. Registration form with payment guarantees placement in class. Messages can be left on the office-recording machine after working hours or on weekends.

**TO REGISTER BY MAIL:** Please complete and return the registration form accompanied by a check payable to Monmouth University to cover the total course fee (s). If payment is made using MasterCard, AMEX, Discover or VISA, complete information and a signature must be provided on the registration form.

**FEES:** Each course costs \$985.00; textbook and instructional materials are not included;

**COURSE CANCELLATION:** If a course is cancelled, registrants will be notified by phone. A full refund for the course will be provided, or an individual may sign up for the same course to be held at a later date.

**REFUND POLICY:** To withdraw from a class, an individual must notify the office in writing or by phone NO LATER THAN 3 BUSINESS DAYS prior to the class date. A full refund will be provided if this procedure is followed. No refunds will be given if an individual cancels a registration 0-3 business days prior to class. "NO SHOWS" will pay full tuition, no refunds will be provided.

**DISCOUNTS:** If three or more persons from the same organization register for a course at the same time, a 10% discount is extended. Special group rates are available if 6 or more persons register at the same time.
