Potential Cost Drivers for Each Variable & Mixed Cost

- •Cost of goods sold (wood and hardware) Driven by the number of cabinets produced, since more cabinets require more materials
- •Finishing costs (paint and stain wood/finish products) Driven by the surface area of cabinetry or number of units produced, as more cabinets need more paint and stain
- •Shop propane and heat Driven by the size of the building or number of production days, as heating needs increase with space and usage
- •Medicare Driven by total payroll, since Medicare taxes are based on wages paid
- •Electricity to building Driven by machine hours or workshop size, as energy use rises with production time and space

Product Cost or Period Cost?

- 2.Cost of goods sold (wood and hardware) PRODUCT
- 3. Finishing costs (paint and stain wood)/finish products PRODUCT
- 4. Electricity to building PRODUCT
- 5. Business insurance PERIOD

- 7.Rental space for trailers PERIOD
- 8. Shop propane and heat PRODUCT
- 9. Business certifications and licenses PERIOD
- 10.Medicare PERIOD

- Is this expense unaffected by how much the business produces or how many tasks are completed?
 Does this expense fluctuate in direct relation to production
- volume or the amount of work being done
- 1. Does this expense combine a steady, fixed component with a part that varies depending on output or activity levels?
